ISSUE OF SHARES UNDER PLACEMENT

On 1 July 2016, Latrobe Magnesium Limited (ASX:LMG) has made a placement of 30,000,000 fully paid ordinary shares at \$0.036 per share to S A Short Pty Ltd ATF The Short Super Fund pursuant to a Share Acquisition Agreement. Under the terms of this agreement, LMG now owns all of the shares in Ecoengineers Pty Ltd, which previously owned 50% of the LMG hydromet process. These shares will be escrowed until 31 December 2016. These new issues are within the Company's existing capacity under ASX Listing Rule 7.1. Appendix 3B is enclosed.
