### **ISSUE OF SHARES UNDER PLACEMENT**

On 14 July 2016, Latrobe Magnesium Limited (ASX:LMG) has issued 38,461,538 fully paid ordinary shares at \$0.026 per share to sophisticated and professional investors pursuant to a private placement, raising gross proceeds of \$1,000,000.
